One article was reprinted and provided many music and dance records for the Stockton Library at UOP. Bev encourages people to go to the record Library for information on music, dance notes or viewing dances on video. The library is open every day including Sunday afternoons. The music library is located on the Second floor of the UOP campus in Stockton, CA. Secretarial report—The office machine still needs repair. \$150 was already paid however the machine is still not operating. The A3 volume will be reprinted and no changes had to be made.

CALENDAR OF EVENTS: Ed Kremer was not present.

NORTH-SOUTH COMMITTEE:

Ruth Ruling reported about the meeting which was held at 10 am, 10-21-90. There were two representatives from the South, Audrey Silva and Alice Sterling. Many topics were discussed. They have begun working on Publicity for Statewide.

INSURANCE:

Later he received a copy of the Square Dance Insurance Program from the United Square Dancers of America. This provides clubs with the necessary information on the insurance. He also stated that there will be no increase in enrollment fees. There is no charge for co-insurance. Frank and Elsa will be mailing out the necessary information to the clubs so they can be insured. If there is a temporary change of location the club must notify Frank 60 days in advance so the insurance Co. will be notified and the club can be covered. The insurance requires 45 days but all information must be sent to the Bachers prior to that 45 day deadline. Elsa will notify John Meyer when the new package goes through and when the old insurance comes up, probably in December. A Special Thanks to Ray Augustine, from the Federation North, for all of his help in sending insurance information to Frank and Elsa Bacher.

INSTITUTE:

Suzanne Rocca-Butler was not present. Ruth Ruling gave the report for Suzanne. The Fresno institute had 48 paid admissions, it was very successful. Suzanne will send a final report for the Dec. 2nd meeting.

Their tentative ideas are: to find a location for the Festival, perhaps Sonoma: to find a date, perhaps early March or late April. They do have a publicity deadline of Jan. 1, 1991 for Let's Dance, Berkeley's news letter and Sacramento's Latest Steps.

STEPS AND STYLING: No one was present to give report.

GOOD OF THE ORDER:

There will be a Presidents International Grand Ball on December 29,1990. It will be held at the Veteran's Memorial Building in Sonoma, CA. Everyone should come in costume, either a folk dance costume or vintage.
