# Standing Committees

Dance Research

#### Insurance

79 clubs are insured in 1995.

\$13,893.10 total money has been received.

\$13,140.30 total money has been paid out. Of this \$12,763.80 was paid to USDA for insurance premiums and \$359.50 for insurance chairment expenses.

Festival Advisory

Millie had an out-of-town obligation but had talked to Carlos. She is working on the book and planning to publish it this year.

#### Statewide

Bill and Louise were out of the country but had submitted a tentative plan for Statewide.

The Board went over the plan very carefully and made several suggestions which Carlos will submit to Bill and Louise.

# Costume Research

No progress has been made on articles for Let's Dance. The Board felt the costume articles were important to Let's Dance. Eleanor will try to work something out.

#### Calendar

Genevieve had sent forms to all the clubs soliciting information for a new directory. Therefore she has most of the information needed for a calendar. She will ask Ed Kremers to help her by proofing it. Publishing will be discussed later.

#### Bylaws

Carlos has gone through the bylaws up to page 12. They really need a lot of revising to be workable. The Articles are fine and should not be touched but our bylaws (working rules) need to be changed due to changes made in the Federation. Ray felt he did not have a correct copy. Dolly moved that Changs be given permission to publish the "History of the Folk Dance Federation" in their bi-monthly bulletin. Leona seconded the motion and it was passed. An amendment was suggested "that the article be followed by the information on how to order a copy of the book". Amendment was moved, seconded and passed.
