FOLK DANCE FEDERATION OF CALIFORNIA BOARD OF DIRECTORS MEETING HARVEST FESTIVAL FRESNO, CALIFORNIA October 18, 2008

The meeting was called to order by President Bill Lidicker at 11:40 a.m. Fran Ajoian, on behalf of the Fresno Council, welcomed the attendees to the meeting, the institute, and the evening dance. Louise Lidicker agreed to be secretary pro tem in the absence of Teddy Wolterbeek.

Directors present were: Denise Heenan, Bill Lidicker, Louise Lidicker, Loui Tucker, Vick Vickland, and Sabine Zappe. Guests were: Dick Rawson, Karen Wilson-Bell, Fran Ajoian, Michael Norris, Kathy Hindman, and Lori Urso. A quorum of the Board was not present.

The minutes of the September 14, 2008, board meeting were read and approved.

Treasurer's Report on our financial status as of October 15, 2008, was presented by Sabine Zappe, who had questions about the identification of funds for subscriptions to "Let's Dance!" and the amount of money to be kept in the checking account. An early draft of the Statewide 2008 financial report was expanded and clarified. The Federation had a profit of \$35.07 for that event. Many receipts have been submitted to her for payment without proper documentation, so she presented a "Request for Payment" form, which will be modified and used, along with receipts, whenever anyone wants payment for Federation expenses. Bill reported on correspondence with Wells Fargo Bank regarding their failure to transfer signatures for our account when it was transferred to San Jose.

Fran reported that clubs in the Fresno area have received fraudulent bills purporting to be from a California State department. She contacted the post office and verified that these were fraudulent, and wanted to alert other clubs and the Federation to be on the look out for such bills.

In Gary Anderson's absence, Bill read his report. Gary is retiring from his printing business and will be working from his home. This has required that he purchase new labor-saving equipment for the publication of "Let's Dance!" and the costs will probably go up. The latest magazine was printed on this equipment and looks very good.

The Membership Chair, Sidney Messer, has a badly broken arm and was unable to attend. There was no membership report, but Bill reminded the group that work was going forward on establishing a Family Member category in our Bylaws. Discussion was deferred because of time constraints.

Institute Committee: Denise Heenan reported on the day's institute with teachers Judy Yamahiro and Bill and Louise Lidicker. The January 10, 2009, Heritage Festival will

have an institute with registration at 1:00, dancing at 1:30-4:30, with Craig Blackstone teaching Italian dances and Lynn Overtree and Tony Canavarro presenting Romanian, Russian, and Armenian dances from Stockton. She also reported that Judy Yamahiro had joined the committee.

Dick Rawson, Chair of the 501(c3) ad hoc committee has been working on the complicated forms necessary to file for change to this status. There is a question in regard to payments to the editor of "Let's Dance!" who is a Board member. Dick and Bill are working together to get the necessary information. Possible amendments to the Bylaws were included in the call for this meeting, and will soon be presented formally to the Board.

Written Committee reports received and read by Bill:

Bill Wenzel, Research Committee Chair, commented on integrating new committee member Toba Goddard into the program. Member Rick Sherman has been in the hospital with cancer and a stroke, and the Board will send him a card.

Insurance Committee Chair, Elsa Bacher. There ensued a discussion on the National Folk Organization's insurance plan vis a vis the Federation's. Loui will pursue getting more detailed information on the National Folk Organization policy.

Nominating Committee Chair, Toba Goddard, reported that the committee is currently seeking qualified people for Federation officers.

Promotion Committee Chair, Ann Brown, reported that she has solicited and received final reports for the three recent grants awarded.

Loui Tucker presented a revised letter requesting e-mail addresses of Individual Members and Group Members, which will be mailed out.
